2. THE TEST ON PRODUCTION VALUE, ADDED VALUE ON COMPARABLE PRICE ACCORDING TO THE SYSTEM OF PRICE INDEXES

To implement the use of the system of price index to replace the table of constant price, the Department of National Account Statistics is, in collaboration with the Department of Trade and Price Statistics, testing the calculation of GO and VA in 64 Provincial Statistics Offices. Results of the test show that the change according to the above direction would help overcome many shortcomings. However, in order to put the above method into actual application, it is necessary to concentrate steering efforts to educate Provincial Statistics Offices on a unique understanding of the computational procedure, make additional improvements to the system of price index by region or province.

6. QUANG TRI WITH THE DEVELOPMENT OF FARM ECONOMY

Basing on data collected for Quang Tri province in recent years, the author has analyzed and assessed the development of farm economy in districts of Quang Tri province. According to the author, the farm economy is evenly growing in districts. At present, Quang Tri has 525 farms, of which 253 farms are in Cam Lo, 214 in Vinh Linh and 24 in Duong Hoa.

Although the farm size in Quang Tri is not so large, they have had a great impact to the change in economic structure; creating 1680 jobs and generating a big amount of products valuable to 14.3 billion, of which 82.6% are goods.
