5. MAKING A STUDY OF SOME NEW INTERNATIONAL COMPARISON INDICATORS AND ISSUES CONFRONTED VIETNAM'S STATISTICAL BRANCH

Basing on groups of indicators: economic environment, social environment to exchange information, specialists of the World Paper and the Institute for Monetary Matters have ranked 70 countries according to Wealth Nation Index. The results showed that 5 countries stood at the top: Slovenice, Ixraen, South Korea, Sec and Taiwan, and 4 African countries stood at the bottom. For economic freedom index, it was based on 10 groups of indicators: trading policy, government budget's burden, government interference, bank – finance, salary and price, asset ownership rights and laws. Basing on these groups of indicators, a rank on Index of Economic Freedom for some ASEAN and East Asian countries was conducted. It showed that Singapore was ranked first, and followed by Japan; Vietnam was ranked in a group of countries with very little freedom.
